A roadmap for students – excerpted and adapted, with some alterations for the sake of comprehensibility, from the Doctoral Regulations of the University of Debrecen

Please find below the separate internal curricula of the two sections (Section of Literary and Cultural Studies, Section of Linguistics), each representing a distinct academic field, that comprise the Doctoral School of Linguistics, Literary and Cultural Studies.

SECTION OF LITERARY AND CULTURAL STUDIES

About the order of earning credits in general

(Doctoral Regulations, the University of Debrecen, 2024, 6.§)

(5) The unit of measurement of academic requirements is the **academic point (credit)**. Credits are used for evaluating the performance of the academic, teaching and research duties of doctoral students in doctoral programmes. Doctoral students shall complete 30 ± 3 credits per semester, and a total of at least 240 credits during the entire education. If a doctoral student fails, for reasons imputable to him or her, to earn the required number of credits in a semester, a decision on the suspension of the payment of scholarship stipends and the transfer of the student into the self-financing programme shall be made by the doctoral committee of the disciplinary area. If the doctoral student fails to make up for his or her missing credits within one year, the doctoral committee of the disciplinary area may decide on the termination of his or her student status.

(6) The doctoral student may earn academic (course) credits by way of studying and passing examinations. The number of academic (course) credits required to be earned over the course of first 4 semesters of doctoral education is 12 to 20, with the exact number to be determined by the council of the doctoral school in the educational plan of the doctoral school. The council of the doctoral school may determine the required number of academic (course) credits to be earned per semester. The completion of the credits, on the basis of an examination, paper, report, etc. related to the course, shall be certified by the faculty member in charge of the course in the electronic academic record-keeping system. A credit may only be assigned to a course that is evaluated on a five-grade scale. Credits cannot be earned in the doctoral education by way of language courses.

(7) Based on the decision of the council of the doctoral school, teaching credits may be given to doctoral students for their teaching activities performed. The total number of credits that may be earned from such activity shall not exceed 40 credits over the course of the 8 semesters. 1 credit: teaching 1-2 hours per week, depending on the nature of the duty, over the course of one semester. The teaching duties and the credits assigned for it shall be entered in the electronic academic record-keeping system. The completion of the duty shall be certified by the head of the organisational unit in charge of the given module of teaching.

(8) The doctoral student shall earn the majority of the 240 credits required in the course of the programme (180-228 credits) as **research credits**. The completion of the credits shall be certified on the basis of the written report submitted by the doctoral student by his or her supervisor in each semester. The reports of the doctoral student shall be sent by the supervisor to the head of the doctoral school after the closing of the semesters.

(9) The doctoral committee of the disciplinary areas shall make the decision on the transfer of credits earned or other documented performance by the doctoral student at another university or in the course of a study trip abroad –, on the basis of the prior approval of the student's supervisor.

(11) Students in bachelor's, master's or undivided programmes may also register for courses offered for doctoral students, with the approval of the instructor, but no PhD credit shall be allocated for completing courses offered in bachelor's, master's or undivided programmes.

(12) Doctoral students shall undergo a **mandatory qualification** at the end of the first and the third years, the form of which may vary according to disciplinary area (e.g. progress assessment board, chapter defence, report given before the council of the doctoral school). The council of the doctoral school shall, in the manner and according to the criteria specified in the quality assurance plan of the doctoral school, evaluate the progress made in the doctoral programme, as well as the performance of the doctoral student and the supervisor. The council of the doctoral school shall inform the doctoral committee of the disciplinary area of the result of such periodic evaluation, and if necessary, shall propose the changing of the person of the supervisor or the reclassification of the state-financed doctoral student into a self-financing programme.

(13) *In the course of the doctoral education, at the end of the fourth semester, as the conclusion of the coursework and research stage and as the condition of the commencement of the research and dissertation stage, doctoral students shall take a complex examination, which assesses and evaluates their progress in the academic and research fields.*

(14) *Upon the successful completion of the eight semesters of coursework, the doctoral student is given a pre-degree certificate (absolutorium). The absolutorium is the document evidencing that the doctoral student has completed all academic requirements. The doctoral committee of the disciplinary area may only issue the absolutorium for the doctoral student on the basis of the written approval of the head of the given doctoral school. No absolutorium may be issued to doctoral students who have not acquired the necessary 240 credits. The detailed rules applicable to the issuance of the absolutorium shall be defined by the doctoral committees of the disciplinary areas.*

Ad/12: In the Section of Literary and Cultural Studies (henceforth referred to as SLCS), the two mandatory checkpoints or assessment procedures take the form of the **Topic presentation** (at the end of the first academic year) and the **Chapter defence** (at the end of the third academic year) respectively. Both of these appear under the rubric of research subjects in the curriculum. The *Topic presentation* and the *Chapter defence* are events organised by the doctoral section, and attended by members of the Section Council. These events are organised according to the protocol approved by the Section Council (see below).

Ad/14: In the SLCS, the absolutorium is issued only once the student's performance report closing the 8th semester has been accepted. Should the doctoral student fail to complete all of the required courses or the chapter defence, no absolutorium may be issued even though the student has acquired the required total of 240 credits.

The order of the completion of study and research obligations

The full-time form of regular (organized) doctoral education is regulated by *Ch.4, §6 of the Doctoral Regulations of the University of Debrecen, 2025* (henceforth referred to as *DR*), whereas the conditions of the part-time form of regular doctoral education (students maintaining their employment) are regulated by §11. in the same Chapter of *DR*.

The completion of study and research credits is certified by the faculty member in charge of the course in the electronic academic record-keeping system, with each course evaluated on a five-grade scale.

Each student has to earn at least 27 credits per semester in order to complete that given semester; deviation from this rule can only be accepted in duly justified cases. The missing credits must be made up for in the next semester; i.e., in the next semester, at least $27 + \text{the number of missing credits from the previous semester}$ (27-X) must be completed.

The maximum number of credits that can be earned per semester is 33. The SLCS does not take a stand on the scenario in which the number of credits earned by a student in a given semester exceed the maximum number of 33. Although the electronic academic record-keeping system (Neptun) accepts the extra credits, this can be misleading in terms of the number and proportion of credits already earned with regard to the total number of credits. In practice, students are advised to bear in mind four principal considerations: 1. students must earn 240 credits in order to complete the teaching programme; 2. 90 credits must be earned by the time they register for the complex examination; 3. the minimum number of credits per semester is 27 (thus, semesters with a different number of credits must be planned carefully); 4. a maximum of 20 credits can be earned by taking course credits (See the section on *Coursework in the coursework and research stage*). Students may deviate from the 30 ± 3 standard in exceptional cases only with the approval of the Section (such dispensation is

needed both in the case of a semester with more than 33 credits earned and the subsequent semester with fewer than 27 credits earned).

If a doctoral student fails, for reasons imputable to him or her, to earn the required number of credits in a semester, a decision on the suspension of the payment of scholarship stipends and the transfer of the student into the self-financing programme shall be made by the doctoral committee of the disciplinary area. If the doctoral student fails to make up for his or her missing credits within one year, the doctoral committee of the disciplinary area may decide on the termination of his or her student status .” (*DE BDT Doctoral Regulations, 2022, 6.§ 5.*)

The condition of admission to the complex examination is that the student has earned at least 90 credits in the “coursework and research stage” of the doctoral education (first four semesters), including all “course credits” prescribed in the educational plan of the doctoral school (with the exception of those preparing individually). (*DE BDT Doctoral Regulations, 13.§ 2.*)

Ad: The DSLCS requires students to complete a minimum of 90 credits in the first three semesters of the PhD programme.

Coursework in the “coursework and research stage”

Supplementary information to the DR, 2024, 6.§ 6. (see above): In the SLCS, students are not allowed to earn fewer the minimum number of course credits, not even with a special permission. That is, at least 12 course credits must be earned on aggregate. If a student earns more than 20 credits, the surplus (the number of credits above 20) cannot be acknowledged as part of the 240 credits required for the completion of the first phase of the doctoral training.

Course credits may only be earned during the first four semesters of the teaching programme. Students are advised to register for tutorial and/or workshop seminars only in the 4th semester, while the compulsory, thematic and introductory courses should be taken in the first three semesters.

Students of DE SLCS can earn course credits by taking courses offered by any of the three doctoral schools of the Faculty of Humanities.

Supplementary information to the DR, 2024, 6.§ 9. (see above):

As there is no interoperability among universitites on the level of the Neptun system, in practice, credits earned at another institution of higher education can be accepted only pending the approval of the supervisor; such courses are given special course codes and are linked to the supervisor in Neptun (with the name of the actual instructor specified in the note section). These study units are verified by the supervisor in Neptun after the programme council has accepted the certificate of completion with the actual instructor's original signature.

Courses offered by the SLCS can be divided into four categories: compulsory units, optional units, tutorial seminars and workshop seminars. The topics of the workshop courses are designed with a view to aiding students in the preparation for their complex examinations. General Research Methods (DEAKIDI) is a compulsory course for all PhD students of the university, usually offered in the spring semester.

There are no mandatory courses to be completed by all students of the SLCS.

For PhD students in the *Doctoral Programme in British and North American Literature and Culture, Presentation Skills* (BTP2BA_T_1) (3 credits) and *Review Writing* (BTP2BA_T_2) (3 credits) are compulsory courses. In addition, for students of the *Subprogramme in North American Literature and Culture, Advanced American Studies* (BTP2NA_T_1) (3 credits) is also compulsory. Further information on what courses are compulsory in which subprogrammes is provided by the Neptun system, the Section website (Current courses) as well as the website of the Institute of English and American Studies.

For PhD students in the *Doctoral Programme in Hungarian Literature, Modern Literatures and Cultural Studies*, in the *Subprogramme in Hungarian Literature and Culture, French Literature and Culture, Dutch Literature and Culture, Italian Literature and Culture, German Literature and Culture*, and *Russian Literature and Culture*, Modern Critical Schools (BTP2MÖ_T_1) (3 credits) is compulsory. This course has to be completed once in the course of the doctoral training, preferably in the first term (the course is offered only in the autumn term). The *Doctoral Programme in Hungarian literature, Modern Literatures and Cultural studies* (with the exception of students of the *Subprogramme in Media Studies*) offers as compulsory course, Modern Critical Schools (BTP2MÖ_T_1, 3 credits). This course must be completed in the coursework and research phase; students are advised to take it in the first semester. For students of the *Subprogramme in Media Studies*, the course entitled *Media Studies* (BTP2_MK_T_1, 3 credits) must be completed.

A variety of thematic courses are offered by each subprogramme, which are by default optional for first- and second-year PhD students, but may be made compulsory for students by their supervisors or by the subprogramme director. Possible prerequisites like language competence are described in Neptun as well as the currently valid timetables on the SLCS website, which lists all current courses).

Subprogramme-specific courses: some subprogrammes offer tutorial or workshop seminars every semester. These course units may be taken in any of the four semesters of the coursework and research phase as they address different topics. Tutorial or workshop seminars may be made compulsory for students by their supervisors or by the subprogramme director, while, for other PhD students, these courses are optional.

Description of the study module: This team-taught lecture course introduces doctoral students to aspects of academic conduct and research that are relevant across the widest range of disciplines. Topics covered during the semester include: ethical aspects of research and academic integrity (the ALLEA code); innovation management, aspects of managing intellectual property; research collaboration and technology transfer; the measurability and measuring of academic activity and performance; publication venues and how to evaluate them; gauging aspects of academic publications; visibility and networking; basic research and applied research.

Module name: Presentation skills	Credit value: 3
Category: required (in the Programme for British and North American Literary and Cultural Studies)	
Class format: seminar and workshop	
Language: English	
Mode of evaluation: seminar grade (based on classroom work and the final conference presentation)	
Place in the curriculum (semester): 1–4 semester (offered in every Autumn term)	
Description of the study module: This workshop seminar is designed to help doctoral students improve their professional presentation skills. Conducted in the spirit of collegiality, it aims to improve the self-confidence of students. It is based primarily on active student participation, ranging from making comments and giving advice to each other through chairing sessions in simulated conference situations to giving papers. The course concludes with a professional presentation – either at the biennial conference of the Hungarian Society for the Study of English (HUSSE) or, in alternate years, at some other conference. The conference presentation serves as the course exam. A discussion of successful oratorical strategies is followed by a review of the do's and don't's of presenting, the preparation and discussion of the abstracts and rehearsals of the individual presentations in 5, 10 and 15 minutes. A late session in January serves as the dress rehearsal for the conference, featuring the full presentation of each student.

Module name: Review writing	Credit value: 3
Category: required (in the Programme for British and North American Literary and Cultural Studies); offered in every spring term (semesters 2 and 4)	
Type of class: seminar	
Language: English	

Mode of evaluation: seminar grade (examination in the case of lecture courses)
Place in the curriculum (semester): regularly offered in the Spring term (has to be completed before the complex examination)
Description of the study module: The aim of this course is to develop students' skills in writing book reviews about scholarly works for scholarly journals. Group work will include studying and discussing reviews from various journals, identifying the audience and the aim of reviews, structuring the text, and avoiding typical mistakes. Each student will need to continuously work on a review during the semester. Each student is expected to produce a publishable book review to get credits for the course. Students are encouraged to help and support one another with their comments.

Description of the study module: Key modules of the doctoral training programme, tutorial seminars provide a framework for the extended and continuous work of the doctoral student and their supervisor. It is during these tutorials that consultations about the progress and difficulties of the student's research work, the academic and technical difficulties arising in the course of the writing of the dissertation, as well as publication opportunities and venues, possibilities of conference participation, study trips or research grants. It is also these tutorials that offer the supervisor the chance to monitor the general well-being of the student in their professional care.

The study unit is designed to assist doctoral students in clarifying the theoretical and conceptual background, as well as the interpretative strategies and methodology of their research and proposed dissertation.

Category: compulsory for students in the Programme in Hungarian Literature and Culture; optional for all other students

Class format: seminar

Language: Hungarian

Mode of evaluation: seminar grade

Place in the curriculum: compulsory for students in the Programme in Hungarian Literature and Culture in the 3rd semester; for all other doctoral students, optional in the Autumn term.

Description of the study module: This study unit is designed as an introduction to the basic principles, conceptual frameworks, presuppositions of the major critical/theoretical schools and tendencies of a particular period within modernity. In the course of close reading sessions, students acquire a comprehensive knowledge of the ideological contexts and conceptual frameworks that govern critical discourse in the given period, while they also investigate the extent to which the normative criteria of a certain kind of critical discourse might be valid in the interpretation of texts from other periods and are capable of engaging in a dialogue with different practices of establishing critical norms and presuppositions.

Place in the curriculum: compulsory for students in the Programme in Hungarian Literature and Culture in the 4th semester; for all other doctoral students, optional in the Autumn term. Regularly offered in the spring term.

Description of the study module: This is primarily a methodological study unit. Foregrounding the generic properties of the scholarly essay and the academic review, it is intended to develop the writing skills of students through a series of exercises in creative writing, offering considerable assistance to doctoral students in preparing their own articles and reviews for publication.

PROTOCOL FOR THE TOPIC PRESENTATION (DSLCS UD)

1. The doctoral student is required to take the course entitled *Topic presentation* in the second semester. (It is optional to take the course entitled *Topic introduction* in the first semester as a preparation for this course.)
2. After consulting the subprogramme directors (SPD), the programme director (PD) makes a decision on the date and venue of the *Topic presentation* and notifies the secretary of the doctoral section (SDS), who announces it to the doctoral section, by the end of the semester at the latest. The *Topic presentation* is organised in the exam period, in justified cases it may take place in late August or early September.
3. Participation in the *Topic presentation* is compulsory for the supervisors and subprogramme directors concerned, the reviewers assigned from the programme as well as first and second year PhD students.
4. The topic presentation consists of the 20 to 30-minute long presentation of the **doctoral student** and the academic discussion following it. The presentation should introduce the main ideas of the proposed dissertation, the main hypotheses, the methodological hypotheses, the theoretical background and the bibliographical references to be used. The presentation is followed by an academic debate and an official evaluation.
5. This evaluation is done by a committee of three, whose chair is the subprogramme director (or the programme director in case of the supervisor's involvement or hindrance). In the case of numerous topic presentations on the same day, there may be an overlap in the given roles, thus, the evaluation may be done by a united committee including the supervisors as well. The evaluation consists of a grade and an oral evaluation, which is given at the end of each debate or at the end of the doctoral event.

Stage One: registering for the examination

1. Full-time **doctoral students** submit their academic performance report for term three to the secretary of the doctoral section (SDS) not later than 15 February.

2. After perusing the academic performance reports for terms 1-3, the **SDS** checks

- a, whether the student has obtained the required 90 credits
- b, whether the student has completed all the required subjects
- c, whether the student has a new academic publication (of a paper or book review) to their name in the period since joining the doctoral programme (an official certificate of acceptance from the editors of the publication is also acceptable)

The SDS informs the members of the Council of the Doctoral Section (CDS) about the names of those students who have met the preconditions of registering for the Comprehensive Examination not later than 22 February. The list is also sent by the SDS to the Secretary of the Faculty Doctoral Council (SFDC).

3. The **doctoral student** registers for the comprehensive examination not later than the last day of February, using the registration form of the Doctoral Section. The form can be downloaded from the website of the Doctoral Section and from that of the Faculty Doctoral Council, or obtained in the office of the Faculty Doctoral Council.

4. The **supervisor** evaluates the progress of their candidate, using the purpose-made form: "Supervisor's assessment of the candidate's academic progress" (<https://btkphd.unideb.hu/hu/node/237.>) This assessment, which is a precondition for registering for the examination, has to be submitted simultaneously with the registration to the Secretary of the Faculty Doctoral Council (SFDC).

5. After consulting the students and supervisors about the registration procedure and the examination subjects, the **subprogramme director (SPD)** draws up their preliminary recommendations concerning the examination subjects and the examiners (i.e. a three-member examination committee). This document, which has to reach the SDS by the end of February, makes three recommendations for each examiner, indicating priorities and naming possible substitute members as well, as per 13§ (3)¹ in the *DR*. It also contains recommendations concerning the assigned reading material of the examination: three items per subject, in the region of 60-80 pages per subject – 120-160 pages on aggregate. These assignments may be standard secondary sources in the relevant field.

¹ "The board of examination shall consist of at least three members, and at least one third of them shall be persons who are not in the employment of the institute where the doctoral school operates. The chairperson of the board of examination shall be a faculty member or researcher with the title of full university professor, habilitated university association professor, habilitated college professor, Professor Emeritus or doctor of the Academy. All members of the board of examination shall have academic degrees. The supervisor of the doctoral student may not be a member of the board of examination."

Stage Two: Deliberation

The **SDS (secretary of the doctoral section)** checks formal aspects of the recommended committees, unifies the list of committees (also finalises the list of recommended assigned readings (the avoidance of anomalies for candidates being a chief priority) as well as sending them to the mailing list of the **Section Council**. Approval of this list is carried out by electronic voting by the first week of March (or November, in case of a cross-semester).
2. The **SDS** makes a list of the proposed presidents as well as the two members of the examination committee (also naming two plus two standby members respectively), also approved by the head of the section.).
3. In its March meeting (the third week of March is the regular date / November for cross-semesters), the **FDC** approves or makes the final decision about the candidate's registration, the examination subjects and the composition of the examination committee. Immediately after the CDS's decision, the **secretary of each subprogramme** sends out invitations to the proposed members of the examination committee (the invitations, sent out from the electronic address of the Doctoral Section, bear the signature of the SPD, the SD and the SDS), appealing for a reply as soon as possible. In the case of positive replies, the SDS draws up the final draft of the memo to be sent to the FDC (signed by the SD); if the answer is negative, the SDS proceeds to approach the next name on the list, following the order of priorities among the standby members until the examination committee is complete and the memo can be finalised.

The invitations are to be done through the form used by the doctoral section and all correspondence must be forwarded to (deikdikomplexvizsga@gmail.com) in which the SDS registers the invitation procedure for the doctoral section.

Stage Three: Preliminary arrangements

1. After the FDC's decision, but before the end of March, the **secretary of the subprogramme** asks the **appointed examiners** (members of the examination committee) to double the reading assignment by assigning a further three items per subject (in the region of 60-80 pages per subject, 120-160 pages on aggregate) and send the list to the secretary of the subprogramme within a week of the receipt of this letter.
2. The list of assigned readings for the 'theoretical' part of the complex examination, comprising 12 items, is registered by the **secretary of the subprogramme**, who then sends it via email to the candidate, not later than 10 April (10th Dec for cross-semesters).
3. The deadline for the dissertation proposal of 4000-4500 words (plus bibliography), which forms the basis of the other, 'practical' part of the complex examination, is 31 May. The proposal is sent by the **student** to the **secretary of the subprogramme** in a pdf format – accompanied by the written approval of the supervisor –, who in turn sends it on to the members of the committee and the secretary of the doctoral section. The **supervisor** evaluates the subject, "Hypothesis of Thesis" (BTP2IDI_KUT_9) on a five grade scale in the electronic record-keeping system. The dissertation proposal is sent to the member of the examination committee by the **secretary of the subprogramme**.

4. The final arrangements before the comprehensive examination (negotiations concerning date, time and venue) are the responsibility of the **secretary of the subprogramme**. Information about the final details (date and venue) must reach the **secretary of the subprogramme** by 31 May (December for cross-semesters). The secretary of the subprogramme then advertises the comprehensive examination on the Section website, and sends all the examination details on to the FDC.

Stage Four: The Examination

1. The arrangement of the technical details of comprehensive examinations, conducted between *15 and 30 June (January for cross-semesters)*, is the responsibility of the subprogramme. Travel costs incurred are also reimbursed by the subprogrammes; the technical arrangements of the financial transactions are the responsibility of the staff member of the host institute of the doctoral subprogramme who is in charge of finances.
2. The comprehensive examination consists of two parts. In the theoretical part, the **candidate** gives account of their knowledge of the two subjects (main subject and complementary subject), while the practical part is virtually a defence of the dissertation proposal, during which the candidate presents the results of their research and of further evidence of the progress they have made. The **supervisor** may attend the comprehensive examination; at the end of the proposal defence, the supervisor may participate in the open discussion; the supervisor, however, can participate neither in the actual examination nor in the discussion of the examination committee deliberating about the candidate's final grade.
3. The evaluation of the comprehensive examination takes place in the manner specified in the *Doctoral Regulations*. The result of the examination is announced at the end of the examination; it is the responsibility of the **chairperson of the examination committee** that the minutes reach the **SDS**, who, in turn, makes a duplicate which is made public via the electronic correspondence function of the Section Council. The SDS sends the original copy of the minutes to the FDC.
4. In the event of failure, the comprehensive examination may be repeated once, not later than 31 August (January for cross-semesters). These regulations also apply to the approved postponement of complex exams.
5. “The doctoral student may only register for the fifth semester of the doctoral programme after successfully completing the complex examination. (DR, 13.§ 9.) The **FDC** registers the completion of the complex exam with the technical credit, “Complex exam” (BDTKV), which does not earn any credits.

PROTOCOL FOR THE CHAPTER DEFENCE (UD DSLCS)

1. The **doctoral candidate** must complete the courses entitled Writing a (Sub)Chapter and Chapter Defence in the sixth semester. (Note: the document called “Order of the Chapter Defence” only regulates the first chapter defence at the end of the third academic year, which also counts as part of the mandatory qualification process. Candidates must take the course Chapter Defence in the seventh or eighth semester, too; Writing a (Sub)Chapter must also be taken at least once more, and can be chosen as a research credit 6 times from the third to the eighth semester.)
2. After consulting the subprogramme directors (SPD), the **programme director (PD)** makes a decision on the date and venue of the chapter defence and notifies the **secretary of the doctoral section (SDS)**, who announces it to the doctoral section, by the end of the semester the latest.
3. Participation in the Chapter Defence is compulsory for the **supervisors** and **subprogramme directors**, the **reviewers** assigned from the programme as well as all PhD students (taking language competences into consideration). The chapter defence is a public event, open to all members of the doctoral section.
4. The **doctoral candidate** sends their dissertation chapter in a pdf format – accompanied by the written approval of the instructor – to the secretary of the subprogramme by 31 May (31 December for cross-semesters) or 10 days prior to the appointed date of the chapter defence, with the approval of the supervisor. The secretary of the subprogramme forwards the chapter to the members of the committee and the secretary of the doctoral section. The minimum length of the dissertation chapter is equal to that of the dissertation proposal, i.e. 4000-4500 words (plus bibliography).
5. The chapter defence is chaired by the **programme director** (or the subprogramme director). First, the two appointed reviewers present their evaluation, then a discussion follows with the rest of the participants. The candidate responds to the questions or comments from the reviewers. The debate is followed by an official evaluation.
6. The candidate’s performance is evaluated by the previously appointed three-member committee, which consists of the chair, the relevant subprogramme director (or the programme director in case of the supervisor’s involvement or hindrance), and the two reviewers of the chapters. The evaluation consists of a grade and a detailed oral evaluation, which is given at the end of each debate or at the end of the doctoral event.

PROTOCOL FOR THE PRELIMINARY DEFENCE (UD DSLCS)

1. The preliminary defence is arranged as part of the degree conferment procedure, maximum six months prior to the deadline to submit the doctoral thesis.
2. The participation of at least five researchers with academic degrees is required for the preliminary defence, out of whom a minimum of three form the defence board. At least one third of the members of this committee are not instructors at the doctoral section. The chairperson of the preliminary defence is a core member of the doctoral section. The chairperson and members of the defence board pertaining to the preliminary defence are appointed by the doctoral section.
3. Before evaluation, the secretary of the doctoral section shall send the dissertation submitted for preliminary defence to the University and National Library for screening for duplicate text/textual overlaps (crosscheck@lib.unideb.hu). The library shall prepare the document containing the result of screening within 3 business days, and the secretary of the doctoral section shall forward it to the PhD candidate. The doctoral student and the dissertation supervisor shall submit a declaration in addition to the result of the analysis of textual overlap of the dissertation submitted for the preliminary defence. In this declaration, the doctoral student shall prepare an explanatory note covering each of the publications referenced in the dissertation, and the dissertation supervisor shall declare that the dissertation was prepared in accordance with the work plan previously drawn up, in compliance with the norms of academic ethics.
4. The secretary of the doctoral section shall forward the result of the screening as well as the supervisor's and student's declarations to the preliminary opponents (an original copy of the documents shall also be sent for better legibility). In their written evaluation the opponents shall state that on the basis of available data, the dissertation meets the requirements of publication ethics. If the text of the dissertation is changed or expanded significantly from the version examined at the preliminary defence, the analysis of textual overlap shall be conducted again before the public defence. The form on screening for duplicate text (declarations both for the candidate and the supervisor) may be downloaded from [Forms and documents in English | Bölcsészettudományi Doktori Tanács](#)
5. The subprogramme shall agree on a date for the preliminary defence with the chairperson and appointed opponents and create the invitation for the event. The secretary of the doctoral section shall forward this invitation to members of the doctoral section and advertises this event on the doctoral section's website.
6. The preliminary defence is public at the doctoral section. Access to the dissertation is provided by the secretary of the doctoral section.
7. The preliminary defence is organised by the subprogramme. Travel costs incurred (in justified cases accommodation costs as well) are also reimbursed by the subprogrammes. An honorarium may be paid to the chair and the defence board, depending on the financial situation of the subprogramme.

8. A written record and an attendance register of the preliminary defence shall be drawn up. The form for the written record of the preliminary debate may be downloaded from this link [Forms and documents in English | Bölcsészettudományi Doktori Tanács](#).

9. The previously written opponents' evaluations and the comments at the defence shall be enclosed with the record of the preliminary defence. The subprogrammes shall forward the record and the attendance register to the secretary of the doctoral section, who, after archiving the original copies, will forward all the documents (including the ones related to the text screening) to the secretary of the Faculty Doctoral Council and members of the Doctoral Council.
